

Citizens of the following countries DO NOT require preapproval for issuing a Visa to enter Jordan (Form-A).

Accordingly, passport holders of the following countries can obtain their Visas either upon arrival to Jordan (24/7) or by applying to the consulate department.

Countries not requiring prior visa clearance:

**Asia:** Bahrain (Gratis), Bhutan, Brunei, China, Hong Kong (Gratis), Iraq (resident permit holders, in UK only), Indonesia (Domestic Helper should apply visa form B), Israel, India, Japan, (Gratis), Kazakhstan, North Korea, South Korea, Kuwait (Gratis), Kyrgyzstan, Lebanon, Malaysia, Maldives, Oman (Gratis), Palestinian Territories (Only for who holds Palestinian ID), Qatar (Gratis), Saudi Arabia (Gratis), Singapore, Syria (Gratis), Tajikistan, Taiwan, Thailand, The Island of Burma, Timor-Leste, Turkey (Gratis), Turkmenistan, United Arab Emirates (Gratis), Uzbekistan.

**Africa:** Algeria (Gratis), Cape Verde, Comoros, Egypt (Gratis), Lesotho, Malawi, Mauritius, Morocco, (Gratis, Female (18-35) Apply Visa Form B), Rwanda, Sao Tome and Principe, Seychelles, South Africa (Gratis), Swaziland, Zimbabwe.

**Europe:** Azerbaijan, Andorra, Armenia, Austria, Belarus, Belgium, Bosnia and Herzegovina, Bulgaria, Croatia, Czech Republic, Cyprus, Denmark, Estonia, Finland, France, Germany, Greece, Georgia, Hungary, Iceland, Ireland, Italy, Kosovo, Latvia, Liechtenstein, Lithuania, Luxembourg, Macedonia, Malta, Monaco, Montenegro, Netherlands, Norway, Poland, Portugal, Romania, Russia, San Marino, Serbia, Slovakia, Slovenia, Spain, Sweden, Switzerland, United Kingdom, Ukraine, Vatican City.

**South America:** Argentina, Bolivia, Brazil, Chile, Dominica, Ecuador, Falkland Islands (overseas territory of the United Kingdom), French Guiana (overseas department of France), Guyana, Paraguay, Peru, Suriname, Uruguay, Venezuela, Bahamas, Antigua and Barbuda, Barbados, Trinidad and Tobago, Jamaica, Saint Kitts and Nevis, Saint Vincent and the Grenadines, Saint Lucia, El Salvador, Grenada, Guatemala, Costa Rica, Mexico, Panama, Dominican Republic, Nicaragua, Haiti, Honduras.

**North America** Aruba (overseas country in the Kingdom of the Netherlands), Bermuda (overseas territory of the United Kingdom), British Virgin Islands (overseas territory of the United Kingdom), Cayman Islands (overseas territory of the United Kingdom). Canada, Clipperton Island (overseas territory of France), Greenland (overseas territory of Denmark), Guadeloupe (overseas department of France), Martinique (overseas department of France), Montserrat (overseas territory of the United Kingdom) Navassa Island (overseas territory of the United States), Netherlands Antilles (overseas country in the Kingdom of the Netherlands), Puerto Rico (overseas territory of the United States), Saint Barthelemy (overseas territory of France), Saint Martin (overseas territory of France), Saint Pierre and Miquelon (overseas territory of France), Turks and Caicos Islands (overseas territory of the United Kingdom). United States, United State Virgin Islands (overseas territory of the United States).

**Oceania:** American Samoa (overseas territory of the United States). Australia, Baker Island (overseas territory of the United States), Cook Islands (territory in free association with New Zealand). Fiji, French Polynesia (overseas territory of France), Guam (overseas territory of the

United States), Howland Island (overseas territory of the United States), Jarvis Island (overseas territory of the United States), Johnston Atoll (overseas territory of the United States), Kingman Reef (overseas territory of the United States). Kiribati, Marshall Islands Micronesia. Midway Atoll (overseas territory of the United States). Nauru, New Caledonia (overseas territory of France). New Zealand, Niue (territory in free association with New Zealand), Norfolk Island (overseas territory of Australia), Northern Mariana Islands (overseas territory of the United States). Palau, Palmyra Atoll (overseas territory of the United States). Papua New Guinea, Pitcairn Islands (overseas territory of the United Kingdom). Samoa. Solomon Islands, Tokelau (overseas territory of New Zealand). Tonga. Tuvalu. Vanuatu, Wallis and Futuna (overseas territory of France), Wake Island (overseas territory of the United States).

## Notes

How to get your visa for all above nationality?

1. Any visitor intending to cross into Jordan via King Hussein Bridge (Allenby), then he/she has to get the visa in advance from any Jordanian Embassy.
2. Any visitor intending to cross into Jordan via Wadi Araba Boarder crossing (Aqaba) then he/she has to get the visa in advance from any Jordanian Embassy.
3. For those intending to cross via Wadi Araba Boarder crossing (Aqaba) and they are in possession of the Jordan Pass and are staying in Jordan three night and more please note that you will be exempt from visa for the latter Border crossing.
4. Holders of Diplomatic, Official, and Service Passports whom are in possession of a Note Verbal can get their Gratis visas from the consulate by filling Form A (excluding countries not mentioned above as the need to apply via Form B).

Please submit originals and copies of all documents listed below:

1. One recent photo.
- Scanned photos printed on ordinary paper will not be accepted.
- Please stick the image on the designate area and do not staple or paper clip it.
2. Completed visa application form provided below (Form-A).
3. Original passport which must be
- Two blank visa pages required;

- A valid passport (six months at least from date of application).
4. Visas fees and types
- Single Entry Valid for two months from date of issue (£67.50 Postal order).
- Double Entries Valid for three months from date of issue (£97.50 Postal order).
- Multiple Entries Valid for six months from date of issue (£187.50 Postal order).
- This visa is valid to enter Jordan from date of issue.
- All visas validity for the purpose to enter Jordan not to reside in Jordan for long time.
- Visa fee is non-refundable.

Family groups will be charged for two forms only (£15.00 Postal order) on applying instead of being charged individually, this is apart from any visa fees.

### IMPORTANT!

Groups of five persons or more are exempt from any entry visa fees if

- Their staying would be more than three days in Jordan.
- Their visit to Jordan has to be arranged by an accredited Jordanian tour operator with a government certified tour guide ([www.visitjordan.com](http://www.visitjordan.com)).

Only Postal Orders are accepted (Made payable to The Embassy of Jordan), please DO NOT send Cheques or Cash. - If there is more than one applicant the total fees of all applicants can be paid on single postal order.

How to submit your visa application Form?

Applications can be submitted in person or by post.

If you apply in person at the consulate

- Your Visa applications can be submitted on behalf of other applicants.
- Children require visas and fee is same as adults.
- There is no appointment system.
- Lodging Visas / Documents (Monday–Friday) 1000–1300.
- Collection working days (Monday–Friday) 1430-1600.

The average processing time for a Jordanian visa is between (4 to 5) working days, but may take considerably longer if additional documents are required.

☐ To apply for Jordanian visa by post

- Post the above documents by special delivery (this service is available from the post office) make note of reference no. /tracker number for your

reference. This is useful to track is that we have received your application.

- Include a self-address envelope (pre-paid special delivery envelope) for the return of your certificate back once we have received it from Jordan.

- Applications from Republic of Ireland a self-addressed envelope empty (write your name and address on the envelope) and attached (£10 cash) for the return of your certificate.

- The embassy is not responsible for any lost documents by post.

Visas are normally posted within two weeks. You are therefore advised to submit your application well before the date on which you are planning to travel.
